MEMORANDUM OF AGREEMENT

Know All Men By These Present:


This Memorandum of Agreement, made and entered into by and between:

 **PHILIPPINE MERCHANT MARINE ACADEMY**, with office and postal address at San Narciso, Zambales, Philippines, represented by its Superintendent, **RADM RICHARD U RITUAL**, hereinafter referred to as the Party of the First Part;

-and -


 **VIVAROSE ENTERPRISES.**, a company duly registered and existing by virtue of the laws of the Philippines, engaged in **LAUNDRY SERVICES**, with office address at **Brgy Patrocinio, San Narciso, Zambales**, herein represented by its owner / Manager **CAPT EMERSON P ROSETE**, by virtue of the powers conferred upon her hereinafter referred to as the **Contractor**;

WITNESSETH

 Whereas, the Academy is mandated by law to provide training and development of Merchant Marine Officers and other professional and skilled manpower in the fields of Maritime services;

Whereas, accepted and approved job specification in connection with the laundering of all Midshipmen's uniforms such as GOA Black and White (1 set), Summer White (2sets), Khaki (2sets), Camouflage (1pc), Cover All (1pc), White T-shirts(10pcs), Towel (2pcs) , Duty Blue(1 pc) and new uniform (1set) shall be made a part of this agreement;

Whereas, after the standard evaluation of qualified bidders and bidding process conducted by the Academy, the Contractor was determined to be the winning bidder whose offer is the most advantageous to the government based on the criteria/ specification required by the Academy;

 Now therefore, for and in consideration of the foregoing premises, both parties agree to the following terms and conditions, to wit:

1. That the Academy shall pay the contractor on laundry services the following amount per items, as follows:

That the contractor shall render service which shall be up to par with the industry's standards of excellence with all the amenities agreed upon during the bidding process.

2. The contractor is obliged to post a performance bond based on the contract amount in any of the following manner:
 - a. Cash, manager's check or cashier's check – bond equivalent to five percent (5%) of the total contract price; or
 - b. Surety bond – bond equivalent to thirty percent (30%) of the total contract price.
3. In the event of the contractor through his own fault or negligence losses or cause to destroy the materials to be laundered in the process of laundering, said contractor shall pay or restitute the damaged caused by him.
4. That the Academy reserves the right to terminate the services if or any of all contractor whose services shall fall below standards.
5. The duration of this Agreement shall be for six month starting June 01, 2014 to November 30, 2014 unless earlier terminated on grounds contained in this agreement.
6. The Academy reserve the right to renew the contract of the Contractor at the same terms and conditions for another term if the latter has satisfactorily fulfilled its obligations.
7. That any and all violation of the condition of this contract shall subject the guilty party to the payment of liquidated damages under RA 9184, aside from cost of suit and attorney's fees.
8. The two parties hereby agrees that all legal actions arising out of this Agreement shall be instituted in the Regional Trial Court (RTC) – Iba, Zambales.
9. This Memorandum of Agreement shall take effect on the date the Parties affix their signatures herein.
