



## INVITATION TO BID PROCUREMENT OF HIGH VOLTAGE AND CRANE SIMULATOR

1. The PHILIPPINE MERCHANT MARINE ACADEMY, through **Fund 101**, FY 2021, intends to apply the sum of **THIRTEEN MILLION THREE HUNDRED THIRTY-FIVE THOUSAND SIX HUNDRED SIXTY PESOS (P13,335,660.00)** being the ABC to payment under the contract for the **Procurement of High Voltage and Crane Simulator** with Project ID No. PID No. 2021-020. Bid received in excess of the ABC shall be automatically rejected at bid opening.

2. The PMMA now invites bids for the Project "**PROCUREMENT OF HIGH VOLTAGE AND CRANE SIMULATOR**". Delivery of Goods is required by 180 days. Bidders should have completed within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/ fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
