



**INVITATION TO BID
SERVICE PROVIDER FOR BASIC TRAINING COURSE OF
4CL MIDSHIPMAN/WOMEN**

1. The PHILIPPINE MERCHANT MARINE ACADEMY, through **Fund 164**, FY 2021, intends to apply the sum of **TWO MILLION ONE HUNDRED THIRTY-EIGHT THOUSAND FIVE HUNDRED PESOS (P2,138,500.00)** being the ABC to payment under the contract for the **SERVICE PROVIDER FOR BASIC TRAINING COURSE OF 4CL MIDSHIPMAN/WOMEN** with **Project ID No. PID No. 2021-024**. Bid received in excess of the ABC shall be automatically rejected at bid opening.

2. The PMMA now invites bids for the Project **"SERVICE PROVIDER FOR BASIC TRAINING COURSE OF 4CL MIDSHIPMAN/WOMEN"**. Delivery of Goods is required by **60 days upon receipt of NTP**. Bidders should have completed within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/ fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
